**HEALTH HAZARDS: WARNING**

Harmful if swallowed, in contact with skin, or inhaled. Causes severe eye irritation and irreversible eye damage is possible.

**SECTION 4 - FIRST AID MEASURES**

**IF IN EYES:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

**IF ON SKIN OR CLOTHING:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

**IF SWALLOWED:** Call a poison control center or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by poison control center or doctor. Do not give any liquid to a person. Do not give anything by mouth to an unconscious person.

**FLASHPOINT:** Not combustible

**FIRE AND EXPLOSION HAZARD:** Can release irritating and toxic gases such as hydrogen chloride, hydrogen fluoride, nitrogen oxide in a fire.

## SECTION 6 - ACCIDENTAL RELEASE MEASURES

**IN CASE OF SPILLS OR LEAKS:** Stop the source of the spill if safe to do so. Contain the spill to prevent further contamination of soil, surface water, or ground water. Clean up spills immediately. Observe precautions in Section 8 of this document. Keep unnecessary and unprotected personnel from entering.

**SMALL SPILL:** Absorb small spills with sand, vermiculite, or other absorbent inert ingredients. Place material in a container for proper disposal.

**LARGE SPILL:** Dike spill using absorbent or impervious material such as clay or sand. Recover and contain as much free liquid as possible for reuse or disposal. ## SECTION 7 - HANDLING AND STORAGE

### KEEP OUT OF REACH OF CHILDREN!

**HANDLING:** Use only in a well-ventilated area. Wear proper safety equipment specified in Section 8 when mixing, loading or otherwise handling concentrate. Wash hands before eating, drinking, chewing gum, using tobacco or using the toilet. Remove clothing if pesticide gets inside clothing. Then wash thoroughly and put on clean clothing. Remove PPE after handling this product. Wash outside of gloves before removing. As soon as possible, wash thoroughly and change into clean clothing. Do not reuse container.

**STORAGE:** Do not store below freezing (32°F). If frozen, slowly warm to 80 to 90°F and re-dissolve contents by shaking container before use. Keep pesticide in original container.
