SECTION 2 - HAZARDS IDENTIFICATION SUMMARY

(As defined by OSHA Hazard Communication Standard, 29 CFR 1910.1200)

Light yellow liquid with mild odor.

HEALTH HAZARDS: DANGER - PELIGRO.

Harmful if swallowed, in contact with skin, or inhaled. Causes irreversible eye damage and mild to severe skin irritation.

SECTION 4 - FIRST AID MEASURES

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

IF SWALLOWED: Call a poison control center or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by poison control center or doctor. Do not give any liquid to a person. Do not give anything by mouth to an unconscious person.

IF INHALED: Move person to fresh air, if person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth if possible. Call a poison control center or doctor for further treatment advice.

EXTINGUISHING MEDIA: Use foam, dry chemical, carbon dioxide, or water spray when fighting fires involving this material.

FIRE AND EXPLOSION HAZARD: Can release irritating and toxic gases such as hydrogen chloride, hydrogen fluoride, nitrogen oxide in a fire.

FIRE FIGHTING INSTRUCTIONS: Evacuate area and fight fire upwind from a safe distance to avoid hazardous vapors and decomposition products. Dike and collect water used to fight fire to prevent environmental damage due to run off. Minimize use of water to prevent environmental contamination.

SECTION 6 - ACCIDENTAL RELEASE MEASURES

IN CASE OF SPILLS OR LEAKS: Stop the source of the spill if safe to do so. Contain the spill to prevent further contamination of soil, surface water, or ground water. Clean up spills immediately. Observe precautions in Section 8 of this document. Keep unnecessary and unprotected personnel from entering.

SMALL SPILL: Absorb small spills with sand, vermiculite, or other absorbent inert ingredients. Place material in a container for proper disposal.

LARGE SPILL: Dike spill using absorbent or impervious material such as clay or sand. Recover and contain as much free liquid as possible for reuse or disposal. Allow absorbed material to solidify and scrape up for disposal. After removal, clean contaminated area thoroughly with water. Pick up wash liquid with additional absorbent for disposal. Minimize use of water to prevent environmental contamination.

SECTION 7 - HANDLING AND STORAGE

KEEP OUT OF REACH OF CHILDREN!

HANDLING: Use only in a well-ventilated area. Wear proper safety equipment specified in Section 8 when mixing, loading or otherwise handling concentrate. Wash hands before eating, drinking, chewing gum, using tobacco or using the toilet. Remove clothing if pesticide gets inside clothing. Then wash thoroughly and put on clean clothing. Remove PPE after handling this product. Wash outside of gloves before removing. As soon as possible, wash thoroughly and change into clean clothing. Do not reuse container.

STORAGE: Do not store below freezing (32°F). Keep pesticide in original container. Keep container tightly closed when not in use. Store in a locked storage area. Do not store diluted spray.

CARCINOGEN STATUS: The active ingredient, sodium Acifluorfen, has been identified by US EPA as a probable human carcinogen. Glycol Ether EB is classified Group 3 by IARC.

TERATOGENICITY: No evidence in animal studies.

MUTAGENICITY: No evidence of mutagenic effects during in vivo or in vitro studies.

SECTION 12 - ECOLOGICAL INFORMATION

ENVIRONMENTAL SUMMARY: Do not apply directly to water, or to areas where surface water is present, or to intertidal areas below the mean high water mark. Do not apply where runoff might occur. Do not apply when weather conditions favor drift from treated areas. Do not contaminate water when cleaning equipment or disposing of equipment wash waters or rinsate.
